I hereby waive and will not hold McLean Crew Club, Inc., parents, students, board members, coaches or other persons or entities involved with the MCC team responsible or liable for any accident or injury as a result of participation by me/us and/or my/our child with the MCC team.

I/We hereby release, acquit and forever discharge each and all of McLean Crew Club, Inc., it's officers, board members, employees, coaches, members and agents, including but not limited to, all student members of the MCC team and all parents/guardians of team members, from any and all future liability resulting from any and all claims or causes of action of any type whatsoever, including but not limited to, negligence or strict liability in tort, that I/we and/or my/our child now or may in the future have for any reason, including but not limited to, personal injuries, damage to property, loss of services, medical expenses, and/or losses and/or damages of any and every kind whatsoever that may arise from participation on or with the MCC team, including but not limited to, transportation by parents, guardians, coaches, team members or third-parties to, from and otherwise relating to practices, regattas, fundraisers, and local and out of town trips.

Alcohol and Drugs - The Fairfax County Public School policy regarding the use or possession of alcoholic beverages or drugs will be in effect and strictly enforced during any activity. Honor the restrictions against the use of alcohol, tobacco, and drugs.

Consent to Search - MCC team coaches and chaperones have a legal obligation to control illegal substances on MCC team outings. Equipment - The MCC seeks to equip its Coxswains and Rowers (Rowers) with quality equipment to provide a competitive program in the sport of rowing. Each Rower will be rowing in a shell that costs approximately \$30,000. Each Coxswain is assigned a cox box, which costs approximately \$650. Erg machines cost approximately \$850. The average repair cost on a damaged shell is approximately \$5,000. Shells can be damaged any number of ways (e.g., rack removal and replacement, water
